

Terms of Use for the Smarter World Institute Platform | Hakki Bayraktar | Mohammad Walker

- 1.1. Age Restrictions. You must be at least 18 years old to use the platform. By accepting these terms, creating a platform account, or using the platform, you confirm that you are at least 18 years old. You may not create a customer account unless you are at least 18 years old. If you are a parent or legal guardian allowing a person who is at least 13 years old but under 18 years old (a "Minor") to create a customer account and/or use the platform, you agree to: (i) supervise the Minor's use of the platform and their account; (ii) assume all risks associated with the Minor's use of the platform and their customer account, as well as any resulting liabilities; (iii) ensure that the content on the platform is suitable for the Minor; (iv) ensure that all information provided by the Minor to us is accurate; and (v) provide the consents, representations, and warranties contained in these terms on behalf of the Minor.
- 1.2. Ownership of the Platform Account. The use of the platform requires you to provide complete, current, and accurate information when registering for a platform account. a. Fees: Your use of the platform is subject to the timely payment of all fees. Fees may change from time to time. All fees are exclusive of communication surcharges. You will pay all communication surcharges associated with your use of the platform, which will be itemized separately on an invoice. All fees and communication surcharges are non-refundable. Subscription fees are charged in advance for services. You agree to provide us with accurate and complete billing information (name, address, credit card information, and phone number) and to inform us of changes within 10 days of the change. Variable fees apply, such as costs for Al Review Management, Content Al (for generating pictures and texts by Al). 10 Euros give you approximately 120 reviews, or 105000 words, or 160 pictures. This variable costs will be charged directly to the account users bank account.

Included in each contract are provisions for up to 10 users. Any additional users will be subject to a fee of 119 Euros per month, per contact. This fee will be automatically applied for each user exceeding the included number, ensuring our services can scale flexibly with your business needs.

Only one WhatsApp account will be installed per user (i it is included in the contract) unless otherwise agreed upon in writing. Any exceptions to this rule, including the use of additional account numbers, must be explicitly stated and approved by us in advance. Any additional Whatsapp Accounts will be charged with 114 EUR per account per month.

b. Taxes: You are solely responsible for taxes and other governmental levies ("Taxes") associated with your use of the platform, including any Taxes related to transactions you conduct with your customers. Smarter World Institute may collect Taxes from you as part of the fees, to the extent required by law or deemed appropriate by Smarter World Institute, and all decisions by Smarter World Institute regarding which Taxes to collect shall be final. 6. Time Limitation for Filing Claims

ANY CLAIM OR CAUSE OF ACTION ARISING OUT OF OR RELATED TO THESE TERMS OR THE PLATFORM THAT YOU MAY HAVE MUST BE COMMENCED WITHIN THREE (3) MONTHS AFTER THE EVENT THAT GAVE RISE TO THE CLAIM OR CAUSE OF ACTION, REGARDLESS OF WHEN YOU BECAME AWARE OF OR SHOULD HAVE BECOME AWARE OF IT; OTHERWISE, SUCH CLAIM OR CAUSE OF ACTION SHALL BE PERMANENTLY BARRED.

7. Injunctive Relief

You agree that a breach of these Terms would cause irreparable harm to Smarter World Institute, for which monetary damages would be an inadequate remedy. Therefore, Smarter World Institute is entitled to seek equitable relief, including injunctive relief, in addition to all other remedies it may have under these Terms or at law, without posting a bond or other security.

8. No Waiver

No waiver by Smarter World Institute of any provision or condition of these Terms shall be deemed a continuing waiver of such provision or condition or of any other provision or condition. Failure by Smarter World Institute to assert a right or provision of these Terms shall not constitute a waiver of such right or provision.

9. Severability



If any provision of these Terms is found by a court or other competent authority to be invalid, unlawful, or unenforceable for any reason, such provision shall be eliminated or limited to the minimum extent necessary so that the remaining provisions of these Terms will continue in full force and effect.

10. Change of Control

Smarter World Institute may assign its rights under these Terms at any time without notice to you. You may not assign your rights under these Terms without the prior written consent of Smarter World Institute, which may be withheld at the sole discretion of Smarter World Institute.

11. Entire Agreement

Except as otherwise specified herein, these Terms constitute the entire agreement between you and Smarter World Institute with respect to the Platform and supersede all prior and contemporaneous understandings, agreements, representations, and warranties, whether written or oral, regarding the Platform. These Terms may not be modified, supplemented, or amended by the use of any other documents unless such document is signed by an authorized representative of Smarter World Institute.

Smarter World Institute may enter into a separate agreement with you. The terms of any such separate agreement between you and Smarter World Institute shall be considered a part of your overall agreement with Smarter World Institute. In the event of a conflict between these Terms and the terms of your separate agreement with Smarter World Institute, the terms of your separate agreement with Smarter World Institute shall prevail.

12. Term and Termination

These Terms shall remain in full force and effect for as long as you maintain a Platform account. Sections of these Terms that are intended to survive termination of your Platform account shall continue to be binding even if you are no longer a Platform user.

- a. Reasons for Termination: You agree that Smarter World Institute, in its sole discretion, may suspend or terminate your access to the Platform (or any part thereof) for any reason, with or without notice, and without any liability to you or any third party for claims, damages, costs, or losses resulting therefrom. Suspected fraudulent, abusive, or illegal activity may be grounds for terminating your access to this Platform and reporting you to the appropriate authorities. Smarter World Institute reserves the right to delete Platform accounts that have remained inactive for at least one (1) year.
- b. No Claim to Services Upon Termination: Upon termination, regardless of the reasons leading to such termination, your right to use the Platform ceases immediately. Smarter World Institute shall have no liability to you or any third party for claims for damages arising from such termination or suspension or any other action taken by us with respect to your Platform access.

The arbitration proceedings shall be held in Austria, Vienna. Any award issued in arbitration may be entered in a competent court.

All claims and disputes within this arbitration agreement must be arbitrated or litigated on an individual basis and not on a class basis. Claims of more than one customer or user cannot be arbitrated or litigated jointly or consolidated with those of any other customers or users.

14. Communication and Contact Information

All notices to a party shall be in writing and sent by email. Notices to Smarter World Institute shall be sent to support@smarterworldinstitute.com. You agree that we may send you notices either to the email address you provided during registration or to any other address we have on file. Notices are deemed effective upon receipt.

Smarter World Institute may contact you regarding these Terms using any information you provide or through other means if you do not provide contact information.

When creating a Platform account, you must provide a primary email address to be used for receiving electronic communications related to these Terms. 15. Definitions

"Communication Charges" means any communication service or telecommunications provider fees (e.g., carrier fees) incurred in connection with your use of the Platform.

"Information" refers to data about you and your customers collected by Smarter World Institute on the Platform, including but not limited to information necessary to create a Platform account and use the Platform for its intended purpose.

"Login Credentials" refers to the username and password used to access your Platform account.

"Platform" refers to all services, training, content, features, communication channels, and software or other services or features offered to customers on or through Smarter World Institute's website or mobile application.

"Platform Account" refers to the account you have created to access and use the Platform.
